### For Jeep® CJ-7 and Wrangler Vehicles '87-'95 (YJ) '97-'06 (TJ) and '04-'06 (LJ)

### Cargo Liner Installation

Installation varies depending on vehicle configuration. Designed to be adaptable for all CJ-7 and '87-'06 Wrangler vehicles. For best results, we recommend vacuuming your vehicle carpet before installation. Make sure carpet is dry. The trimming is required to use cargo liner with rear seat & seat belts (if equipped).

#### For '97-'06 Wrangler (TJ):

Use hobby knife to trim sections A, B & C as shown.

#### For '04-'06 Wrangler Unlimited (LJ):

No trimming required.



#### For '76-'86 CJ-7 or '87-'95 Wrangler (YJ):

Use hobby knife to trim only areas A&C if you wish to use the factory rear seat **with** the Cargo Liner.

#### Recommended Use:

Use and Enjoy! Place objects in cargo area without worry about your carpet. When Cargo Liner is dirty, simply remove as needed and hose it off. **Do not** expose to extreme heat such as portable heaters or grills.
