Cargo Liner Installation

Installation varies depending on your vehicle configuration. Designed to be adaptable for all '07-'Current JK Wrangler vehicles. For best results, we recommend vacuuming your vehicle carpet before installation. Make sure carpet is dry.

For 4 Door Wrangler:

No trimming is required, simply place in cargo area.



**To use rear seat with 2 door:
Trim Areas A & B with Hobby Knife**

For 2 Door Wrangler:

Use hobby knife to trim areas A&B if you wish to use the factory rear seat **with** the Ultimate Cargo Liner.

Final Step:

Use and Enjoy! Place objects in cargo area without worry about your carpet. When Cargo Liner is dirty, simply remove as needed and hose it off.

What is not covered:
