Put on safety glasses. Start on Driver's side. Open door and locate Two T40 Torx bolts on the inside door panel. Remove bolts with the T40 Torx bit and ratchet.

Take care to support the mirror on the outside of door to prevent dropping or damaging factory mirror. Retain the factory T40 Torx bolts for reassembly. Factory mirror heads may be re-used.

Locate the filler plate as shown (FIG2). The longer extension tube goes into the bottom hole on the door. Insert through the door into the stock mirror location.

Reinstall the factory T40 Torx bolts into the filler plate as shown above. Tighten with the T40 Torx bit & ratchet. Remove

the lower two T40 Torx bolts in the A-Pillar windshield bracket as shown (FIG4) Retain these bolts for reassembly.

Place the mirror relocation bracket into position, aligning the holes with the holes on the A-Pillar windshield bracket as shown (FIG5). Start by re-installing the factory T40 Torx bolt in the upper hole, but do not fully tighten at this time.

As shown (FIG6), reinstall the lower factory T40 Torx bolt. Tighten top and bottom bolts incrementally until both bolts are tight. Repeat all above steps for passenger side installation.

Mirror Head Installation: At this point, you may either remove, disassemble and re-use your factory mirror heads, or simply install a set of Quadratec replacement mirror heads Part #13111.0333 (sold separately). Properly position the mirror heads for driver use into the

relocation bracket as shown (FIG7). Install Phillips head screw provided with Quadratec mirror head (FIG8), or re-use your factory torx bolt Mirror head hardware. Repeat all above steps for passenger side installation.
