Safety Glasses 4mm Hex/Allen Key T40 Torx Key T40 Torx Bit Socket Ratchet Driver



#### **Bracket Installation:**



Put on Safety Glasses. With the hood securely latched in place, locate the three T40 Torx bolts on both hood hinges and remove them using a T40



Torx bit and ratchet. (it may be necessary to score the paint around the bolts using and razor blade to prevent paint chipping.)



With the Factory bolts removed install the Driver and Passenger brackets as shown with the supplied M8 T40 Torx



bolts and nylon washers. Snug but do not fully tighten the bolts using a T40 Torx bit or key.



On the Passenger side of the light bar, install one of the M8 studs (supplied with Ouadratec light bar) using a 4mm hex key. Also install one of the supplied spacers on the stud.

#### Lightbar Installation:



While supporting the light bar pass the stud through the hole on the Passenger side hood bracket and secure it with a washer, split washer, and nut. Tighten using a 13mm wrench.



Install the spacer between the bracket and lightbar and install stud through the bracket using a 4mm hex key. Install the washer, split washer and nut and tighten with the 13mm wrench as shown above left.



Fully tighten the hood fasteners at this point with a T40 key.



Adjust lightbar to the desired angle, then and tighten the nuts with a 13mm wrench.

Fully tighten all bracket hardware to complete installation.



Before you begin installation, put on safety glasses. Disconnect vehicle negative battery cable and both fuses (B & L) from this harness before installation.

Connect the positive lead (A) on the harness to the positive terminal of your battery. This is the lead on the harness that has the 30/40amp fuse holder.

Secure the harness relay (C) to the firewall of the vehicle. On many models the post that secures the factory wiring harness can be used.


Run the yellow trigger wire (D) along the firewall and pass it through the firewall on the drivers side. Use the supplied zip ties (E) to secure the wire.

Run the lead with the large Deutsch connector (F) to the desired light mounting location. (hood, bumper, windshield hinge mount, etc)

Locate a desired mounting location for the switch (G) inside the vehicle. The switch can be used with our without the included mounting plate.




## A.) Positive Lead

- B.) 30/40 Amp Fuse & Holder
- C.) Harness Relay
- D.) Yellow (Trigger) Wire
- F.) Deutsch Connector
- G.) Control Switch
- H.) Tap Harness
- J.) Red Power Tap (Positive) Wire K.) Negative Lead
- L.) 5 Amp Fuse & Holder

A 12mm hole can be drilled in an interior panel to mount the switch directly to it using the supplied plastic jam nut.

Locate the vehicle's ignition on 12v power outlet (cigarette lighter). Connect the tap harness (H) in-line with the vehicle power outlet harness.



Connect the wires to the interior switch (G) as shown : (I) brown (ground/earth) to the top post. Yellow (D) (trigger wire) to the center post. Red (J) (positive from outlet harness) to the lower post.

Connect the vehicle negative battery cable and negative (ground/earth) connection from the accessory harness to the negative battery terminal.

 $Connect\ the\ Deutsch\ connector\ to\ your$ light. Replace both fuses on the accessory harness, switch on the vehicle ignition and test the system.
