



Ratchet 17mm Socket 17mm Wrench Safety Glasses


Step One

SECURE WINCH PLATE TO BUMPER

Place the Winch Plate on top of the bumper. Line up the outside holes in the plate with the holes in the bumper. Install an M10 Screw and 7/16" Washer through the top of the bumper and an M10 Nut and 7/16" Lock Washer from the bottom in each hole.



Winch Plate to the frame of the vehicle.
