## **Cargo Rack Assembly & Installation:**





Put on safety glasses. Lay rack base (B) flat, install the front (E), back (D), side (C) panels using (16) M5 hex bolts, (32) M5 flat washers and (16) M5 locknuts.




Be sure all support plates on side panels are placed inside the rails of the rack base, then align all holes and progressively hand-tighten with nuts & bolts.





Place the assembled cargo carrier basket onto the 2" support tube (A). Line up the holes and use (4) M8 Allen head

bolts (I), (8) M8 flat washers (J), and (4) M8 locknuts (K) as shown in Figure 6.
