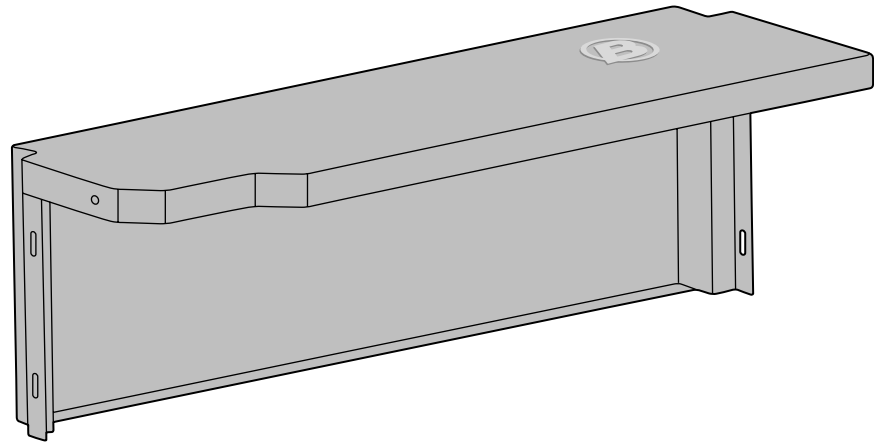

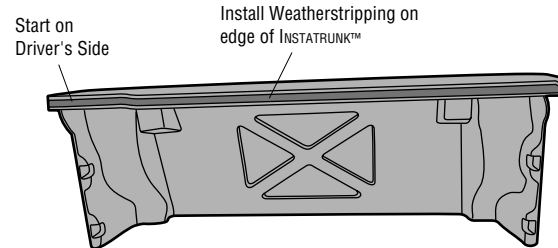
### Tools Needed

Phillips Screwdriver  
Safety Glasses

### Step One

#### Install Weatherstripping.

Locate the Weatherstripping in the parts kit. From the rear of the trunk start installing the weatherstripping along the rear edge so that it will form a seal between the INSTATRUNK™ and the tailgate. Start on the driver's side and work across to the passenger's side. Peel the backing off the weatherstripping a few inches at a time and press the adhesive on the weatherstripping onto the edge of the trunk.

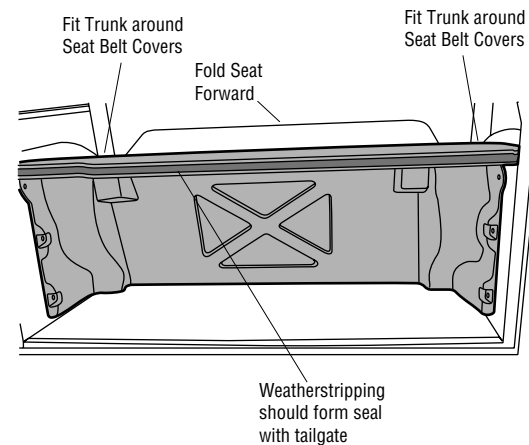


### Step Two

#### Install INSTATRUNK™.

Open the tailgate of the vehicle and lean the rear seat back forward.

Place the Instatrunk™ in the vehicle so that it fits snugly between the wheel wells with the top level with the top of the wheel wells and with the notches around the plastic seat belt covers. Make sure that the contoured edge of the trunk with the weatherstripping is flush against the tailgate. Close the tailgate to check that the weatherstripping forms a seal against the tailgate. Adjust the position of the trunk as needed.



**Note:** In some cases there may be extra padding under the carpet, in this case it may be necessary to remove it for the INSTATRUNK™ to fit properly.



## Caution

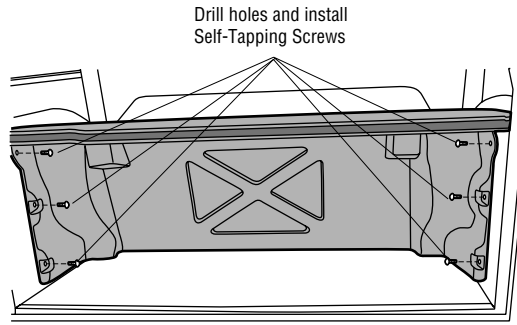
Do not drill into the floor of your vehicle.  
The INSTATRUNK™ must be securely installed in the vehicle during vehicle operation.

### Step Three

#### Install INSTATRUNK™.

Locate the six pre-drilled holes in the INSTATRUNK™.

Install a Self-Tapping Screw at each location.



**Note:** To use the rear seat, use the lever in front of the seat back on the driver's side.
