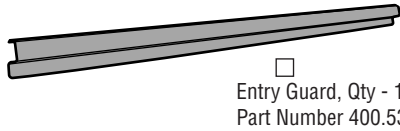

### Tools Needed

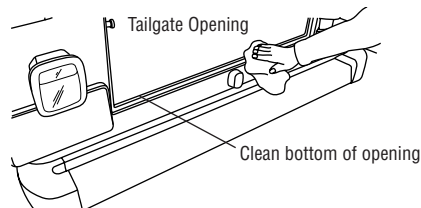
50/50 Alcohol Water Solution  
Clean Cloth  
Pencil

## Installation

### Step One

#### CLEAN TAILGATE OPENING

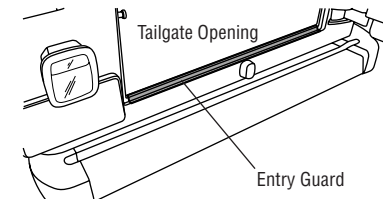
Open the tailgate. Use a 50/50 alcohol/water solution and a clean cloth to clean the area along the bottom of the tailgate opening.



### Step Two

#### INSTALL ENTRY GUARD

Place the Entry Guard in the tailgate opening and center it. Use a pencil to mark the left end of the guard. Remove the Entry Guard from the vehicle and peel the backing off the two adhesive strips on the back of the guard. Place the left end of the Entry Guard on the pencil mark with the right end tipped up. Work from left to right to press the guard down into position. Rub the guard to make sure that the adhesive attaches securely to the vehicle.
