

A Few Words About Product Safety:
Your wiring harness is intended to enhance the function and visibility of your off road capable vehicle. Before installation, please take a moment to review the following safety information

and installation instructions. Important safety information is generally preceded by one of three signal words indicating the relative risk of injury.

The signal words mean:

 WARNING	a hazardous situation which, if not avoided, could result in death or serious injury. You CAN be KILLED or SERIOUSLY HURT if you don't follow instructions.

Wiring Harness Installation:

 CAUTION	IF YOU ARE NOT FAMILIAR WITH 12V AUTOMOTIVE ELECTRICAL SYSTEMS CONSULT A TRAINED AUTOMOTIVE TECHNICIAN.
 CAUTION	DO NOT EXCEED 288 WATTS MAXIMUM DRAW
 CAUTION	DISCONNECT VEHICLE NEGATIVE BATTERY TERMINAL AND REMOVE FUSE (C) FROM ACCESSORY HARNESS BEFORE INSTALLATION.
 CAUTION	MAKE SURE ALL WIRES ARE KEPT AWAY FROM MOVING PARTS OR EXHAUST COMPONENTS. USE THE SUPPLIED CABLE TIES TO SECURE WIRES PROPERLY.

Before you begin installation, put on safety glasses. Disconnect vehicle negative battery cable and fuse (C) from this harness before installation.

Run the switch harness (G) along the firewall and pass it through the firewall on the drivers side. Use zip ties to secure the wire.

Connect the positive lead (A) on the harness to the positive terminal of your battery. This is the lead on the harness that has the 30 amp fuse & holder.


Run the leads with Deutsch connectors (E) to the desired light mounting locations. (hood, bumper, windshield hinge mount, etc)

Secure the harness relay (D) to the firewall of the vehicle. On many models the post that secures the factory wiring harness can be used.

Locate a desired mounting location for the switch (F) inside the vehicle. The switch can be mounted using the adhesive backing.

Wiring Harness Installation:



Connect the switch harness connector (G) to the control switch (F).

Connect the vehicle negative battery cable and negative (ground) connection from the accessory harness to the negative battery terminal.

Connect the Deutsch connectors to your lights. Replace fuse (C) on the accessory harness, and use the switch (F) to test the system.
