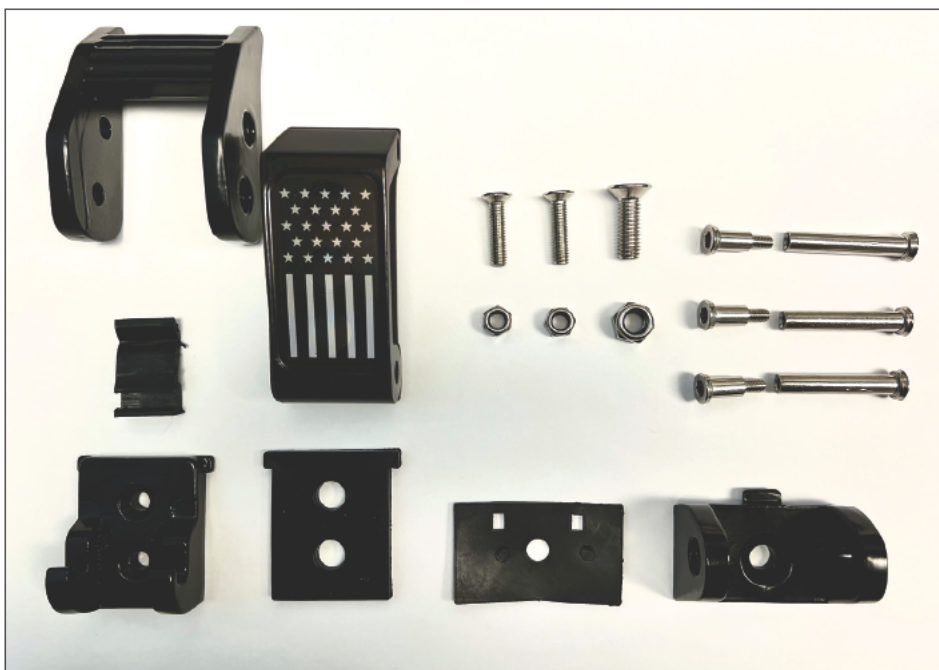
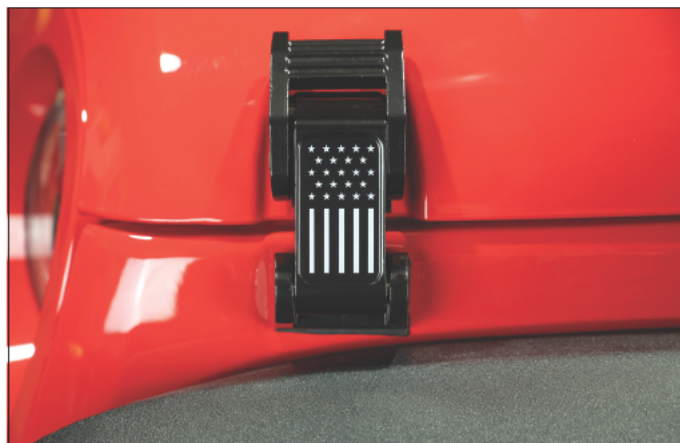

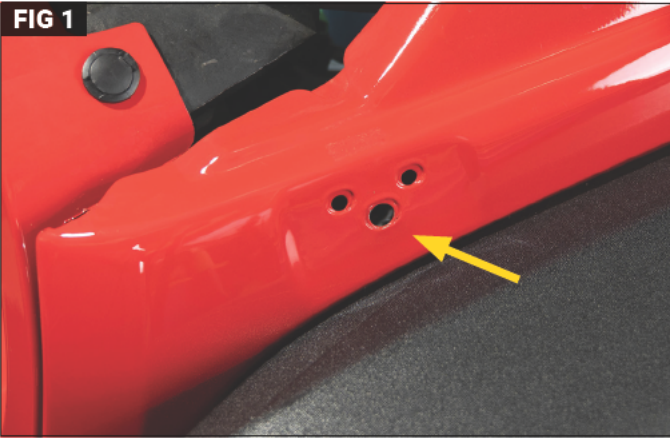

INSTALLATION



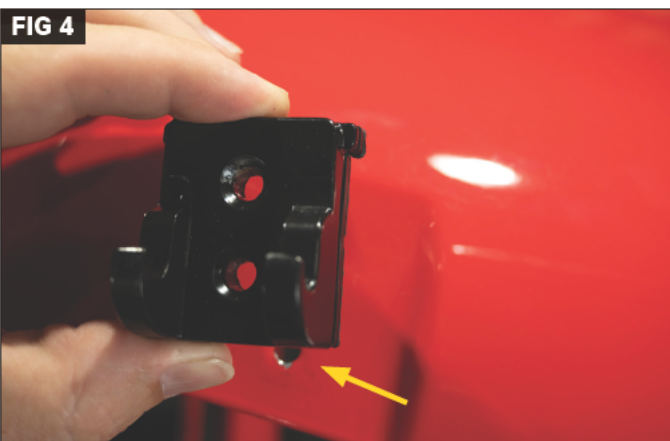
STEP 1

Put on safety glasses. Remove original factory hood catches. Make sure to remove and retain the hood bumper from original fender mount. Clean surface to remove dirt and grime. Locate the mounting hole where the fender mount was removed (Fig 1). Place the fender mount isolator pad between the fender mount bracket and the fender mount location for the hood catch. Using the M8 hex head bolt, mount the bracket to the fender using the larger lower center hole. Tighten the 13mm Nylock nut onto the bolt. A ratchet with an extension and the 5mm hex wrench should be used to tighten the nut while keeping the mount square (Fig 2).



STEP 2

Put original hood bumper on using the tab on the top of the fender mounting bracket (Fig 3).



STEP 3

Locate the 2 vertical holes on the hood. Place the hood mount isolator pad between the hood and the hood catch, making sure that the top tabs and holes for bolts align (Fig 4). Clip the safety snap onto the top of the catch making sure that the snap fits into the corresponding groove on the back of the catch. Using the M6 hex head bolts and 10mm Nylock nut, securely tighten the hood catch to the hood (Fig 5).



STEP 4

Put a hex binding barrel and screw through the lower holes in the latch (Fig 6). Tighten using two 5mm hex wrenches. Position the longer upper part of the latch arm so that the upper holes align with the longer tunnel on the arm. Insert the binding barrel and screw through each side and tighten using two 5mm hex wrenches (Fig 7).

STEP 5

Attach the latch and arm assembly to the fender mount bracket using the remaining binding barrel and screw. Tighten with two 5mm hex wrenches (Fig 8).



STEP 6

To close latch, hook the lower binding barrel over the hooks on the hood catch (Fig 9). Push the upper portion of the latch toward the hood. Make sure the safety snap comes through the opening and secures the latch (Fig 10). To open latch, push down on the safety snap and firmly pull latch away from the hood. You may need to push down on the hood to unhook the lower binding barrels to remove.
