# **TACTIK®** Replacement Grille

### **Installation & Use Instructions:**

For 07' - 18' JK Wranglers #13131-10XX

Lighting Wire With T-Connectors - QTY 1 (Running Light Models Only)
Retaining Clips - QTY 8
Plastic Retaining Push Pins - QTY 6
Rubber Hood/Grille Guard - QTY 1

#### **REQUIRED TOOLS**

Safety Glasses Forked Clip/Removal Tool Phillips Screwdriver Wire Tie (Not Provided)

#### **INSTALLATION - STEP 1**







Put on safety glasses. Open the hood and securely prop it up (FIG 1). Use a forked clip removal tool to locate and remove the six plastic push pins on the factory grille (FIG 2).



## STEP 2







Find the turn signal lights at the bottom of the factory grille and detach them from both the right and left sides (FIG 3). Remove the factory grille (FIG 4).

## STEP 3





Find the plastic light retainers on both the left and right sides of the factory grille and remove them (FIG 5 & 6).

## STEP 4 - If you purchased the Tactik Grille without LED Running Lights please skip to STEP 6










Using the factory plastic light retainers, install them into the replacement grille (FIG 7). Connect the lighting wire harness to the five grille light connectors and secure them neatly with a wire tie (Not Included) (FIG 8).




### STEP 5










Find the side marker light on the drivers side and unplug the wire connector (FIG 9). Using wire couplers, attach one to the green and white wire and another to the black wire. Connect the grille wire harness to the side marker wire, ensuring the black wire connects to the black wire and the red wire connects to the green and white wire (FIG 10).

### STEP 6





Place the retainer clips on the replacement grille and proceed to secure the grille by reversing STEP 1 (FIG 11 & 12).

### STEP 7







We recommend cleaning the grille with rubbing alcohol or alcohol wipes for best results (Not Included). Carefully peel back the adhesive tape while installing the supplied grille/hood weatherstripping along the top edge of the grille (FIG 13 & 14). Installation is now complete.
